5. Planning and Development

Applications granted

DA/2019/0028 Proposed rear extension/alterations (resubmission) - Lyndwood 4, Home Farm Close, East Farndon, Northamptonshire, LE16 9SS

Applications for consideration

DA/2019/0125 Outline application for detached dwelling with double garage – Land adjoining Twin Elms, Marston Lane, East Farndon, Northamptonshire LE16 9SL

A review of previous minutes shows that when a review of the village confines was undertaken by the Parish Council in 2003, the barns next to the Crow's Nest (now called Windmill View) were specifically excluded from the confines, and a map from that exercise shows that this application is beyond the village boundary.

A previous planning application (DA/2010/0750) for outline planning permission appears to be the same as DA/2019/0125. The Parish Council at that time objected on the grounds it was on agricultural land and outside the village confines, and the refusal by DDC at the time also focused on the fact it was beyond the village boundary and its effect on the character of the landscape.

It was noted that the access road to Greenfields gives the impression that the village boundary would naturally fall there. In fact, this road was built, without planning permission, through agricultural land by the owner of Greenfields, who submitted the previous planning application (and undertook various building projects without planning permission). Mr Green, in attendance who used to own Twin Elms, raised the issue that this road has caused 2 problems. Firstly, it has been built over a ditch with no pipe put in place, so that surface water cannot now drain properly. Secondly, the access road was built through the field that acts as the soakaway for the septic tank situated at Twin Elms. He noted that any further development on the agricultural land next to Twin Elms (the site subject to this planning application) would cause even further problems. The residents of Windmill View, in attendance, confirmed that they have no vehicular access (only pedestrian access) to their property via this road.

The Parish Council objected to the planning application on the grounds that:

- It relates to a site outside the village confines
- The proposed site is agricultural land
- It would have a negative effect on the character of the landscape
- Any development could have adverse environmental effects as regards the soakaway of Twin Elm's septic tank and drainage of surface water
- If permission is granted, it sets a very poor precedent that residents can just ignore building laws/regulations and eventually development will be allowed which is contrary to planning principles

6. Other Matters

Neighbourhood Plan and Planning Principles

A review of previous minutes shows that in the past 10 years, the grounds on which the Parish Council have objected to planning objections have been: overlooking other properties; increased traffic generation; using agricultural land; and being outside the village boundary.

Councillors Burton reminded Councillors that, following the attendance in May 2017 of Councillors Burton and Cooper at a Neighbourhood Planning workshop run by Northamptonshire ACRE and subsequent discussion, a decision was minuted in November 2017 to not go ahead with a Neighbourhood Plan the grounds of expense and the long timeline. There is also the issue of relevance for a village of our size which does not have specific building targets in the DDC Settlements & Countryside Plan (2011-2029). Councillor Burton highlighted a report published in October 2018 by NALC which questions the effectiveness of Neighbourhood Plans, particularly in the light of the revised National Planning Policy Framework, running from July 2018. Councillors are also aware of last month's mass resignations from Hallaton Parish Council due to disputes over their Neighbourhood Plan.

The Council agreed to stick to the decision to not go ahead with a Neighbourhood Plan.
